Please provide a brief description of any significant business and legal actions taken by the debtor, its creditors, or the court during the reporting period, any unusual or non-recurring accounting transactions that are reported in the financial statements, and any significant changes in the financial condition of the debtor which have occurred subsequent to the report date.

Castle Arch Kingman was created to develop raw land. With the economic decline the Kingman project has been put on hold until the appropriate time to continue development occurs. It has had no activity since the petition date.

Castle Arch Kingman does not currently have a bank account.

The land held by Castle Arch Kingman was written down to \$7k per acre based upon 4 comparative sales that occurred in 2011 in the same vicinity.

Property tax payable has been accrued to the Accounts Payable account to conform with the accounting software and isn't stated in the taxes payable portion so as to eliminate any duplication of liability.

Interest Expense has been accrued for all of 2011 for the three notes payable to Castle Arch Secured Development Fund.
