ORDERED that proof of claim #27-2 is disallowed except for the Trustee's conceded amount of \$45,000 on the rent claim and Geringer's full asserted amount of \$198,146.13 on the wage and non-rent expense claim, consisting of \$181,667 for back wages and \$16,479.13 for expense reimbursement inclusive of prepetition interest, for a total general unsecured claim of \$243,146.13.
