**ORDER GRANTING LIQUIDATING TRUSTEE'S STATUS REPORT AND *EX PARTE*  
MOTION TO EXTEND DEADLINE TO OBJECT TO A LIMITED GROUP OF CLAIMS  
UNDER CONFIRMED PLAN**

The matter before the Court is the *Liquidating Trustee's Status Report and Ex Parte Motion to Extend Deadline to Object to a Limited Group of Claims Under Confirmed Plan* (the "Motion"). The Court has considered the Motion, the record in this case and applicable law. Based thereon, and for good cause appearing,

**IT IS HEREBY ORDERED THAT:**

- (1) The Motion is **GRANTED**;
- (2) The deadline for the Trustee to object to the following Proofs of Claim filed by Jeff Austin, Douglas Child and William Grundy is extended through May 31, 2014:

- (4) The deadline for the Trustee to assert any rights that he may have against Robert Geringer related to CAREIC Claim No. 27 in any lawsuit the Trustee may file in the future is extended through May 31, 2014;

- (5) The deadline for the Trustee to file objections to the Bierwolf Claim (defined in the Motion) and the S&W Claim (defined in the Motion) is extended through May 31, 2014.
